GA is committed to provide an environment that is safe for children, free from harassment and abuse for everyone, and promotes respectful and positive behaviour and values.

This Policy provides a Code of Conduct forming the basis of appropriate and ethical conduct which everyone must abide by.

This Policy is an essential part of GA's proactive and preventative approach to tackling inappropriate behaviour.

The Board and Chief Executive Officer of GA are committed to ensuring that everyone associated with the organisation complies with the Policy.

#### PART A: MEMBER PROTECTION POLICIES

#### 1. Introduction

Golf Australia (GA) is committed to participation in all aspects of the sport of golf, whatever members" status, ability, social and personal circumstances, in an environment that respects the worth, dignity and equality of opportunity of all people.

GA is committed to the advancement of participation in playing, coaching, administering and working in organisations devoted to golf, based on merit and equal opportunity. GA intends, by this Policy, to ensure that in all their dealings members shall be treated fairly, with respect, and in a manner appropriate to their innate worth and dignity as human beings, and that members shall advance in their chosen field on the basis of merit and achievement, fairly recognised.

GA is committed to providing an environment in which all members feel free to participate and considers that it is sometimes proper to make special provision for disadvantaged groups, and to establish special programs designed to enable their members to overcome any disadvantage and participate in the community on conditions of equality.

#### 2. Purpose of this policy

This Member Protection Policy ("policy") will work towards maintaining ethical and informed decision-making and responsible behaviours within our sport. It outlines our commitment to a person's right to be treated with respect and dignity and to be safe and protected from abuse. This policy informs everyone involved in our sport of his or her legal and ethical rights and responsibilities and the standards of behaviour that are required.

The policy attachments outline the procedures that support our commitment to eliminating discrimination, harassment, child abuse and other forms of inappropriate behaviour from our sport. As part of this commitment, Golf Australia will take disciplinary action against any person or organisation bound by this policy if they breach it.

This policy has been endorsed by the Golf Australia Board and has been incorporated intoour By-Laws. The policy commenced on 23<sup>rd</sup> March, 2012 and will operate until replaced. For information on the rights, responsibilities and requirements for people involved in golf at the state and club level please refer to the member protection policies of the relevant state association or club.

#### 3. Who this Policy Applies To

This policy applies to the following people, whether they are in a paid or unpaid/voluntary capacity:

- 3.1 Persons appointed or elected to Golf Australia boards, committees and sub-committees;
- 3.2 Employees of Golf Australia;
- 3.3 Members of the Golf Australia Executive:
- 3.4 Support personnel appointed or elected to Golf Australia teams and squads (e.g. managers, physiotherapists, psychologists, masseurs, sport trainers);
- 3.5 Golf Australia appointed Coaches and assistant coaches;
- 3.6 Golf Australia representative players
- 3.7 Referees, Match and other officials involved in the regulation of the sport;
- 3.8 Members, including life members of Golf Australia;
- 3.9 Athletes, coaches, officials and other personnel participating in events and activities, including camps and training sessions, held or sanctioned by Golf Australia;
- 3.10 Any other person including spectators, parents/guardians and sponsors, who or which agrees in writing (whether on a ticket, entry form or otherwise) to be bound by this policy.



This policy also applies to the following:

#### 3.11 Member Associations;

Member Associations are required to adopt and implement this policy and to provide proof to Golf Australia of the approval of the policy by the relevant board in accordance with its constitution. Member Associations are required to commend the Club MPP to District members and affiliated Clubs.

This policy will continue to apply to a person, even after they have stopped their association or employment with Golf Australia, if disciplinary action against that person has commenced.

#### 4. Responsibilities of the Organisation

Golf Australia, member associations and affiliated clubs must::

- 4.1 Adopt, implement and comply with this policy;
- 4.2 Make such amendments to their Constitution, Rules or Policies necessary for this policy to be enforceable;
- 4.3 Publish, distribute and promote this policy and the consequences of breaches;
- 4.4 Promote and model appropriate standards of behaviour at all times;
- 4.5 Promptly deal with any breaches or complaints made under this policy in a sensitive, fair, timely and confidential manner:
- 4.6 Apply this policy consistently;
- 4.7 Recognise and enforce any penalty imposed under this policy;
- 4.8 Ensure that a copy of this policy is available or accessible to the persons and associations to whom this policy applies;
- 4.9 Use appropriately trained people to receive and manage complaints and allegations (e.g. Member Protection Information Officers (MPIOs);
- 4.10 Monitor and review this policy at least annually.

#### 5. Individual Responsibilities

Individuals bound by this policy are responsible for:

- 5.1 Making themselves aware of the policy and complying with its standards of behaviour;
- 5.2 Complying with our screening requirements and any state/territory Working with Children checks;
- 5.3 Placing the safety and welfare of children above other considerations:
- 5.4 Being accountable for their behaviour;
- 5.5 Following the procedures outlined in this policy if they wish to make a complaint or report a concern about possible child abuse, discrimination, harassment or other inappropriate behaviour; and
- 5.6 Complying with any decisions and/or disciplinary measures imposed under this policy.

#### 6. Position Statements

#### 6.1 Child Protection

These requirements are developed according to the Creating Safe Environments for Children – Organisations, employees and volunteers. National Framework (July 2005) Community and Disability Services Minister's Conference.

In some States providers of services in that State, no matter where they are based, must also register on-line that they are child safe compliant.

Golf Australia is committed to the safety and wellbeing of all children and young people accessing our service. We support the rights of the child and will act without hesitation to ensure a child safe environment is maintained at all times. We also support the rights and wellbeing of our staff and volunteers and encourage their active participation in building and maintaining a secure environment for all participants.



Golf Australia acknowledges that our staff, members and volunteers provide a valuable contribution to the positive experiences of children involved in our sport. Golf Australia aims to continue this and to take measures to protect the safety and welfare of children participating in our sport by:

#### 6.1.1: Identify and Analyse Risk of Harm

Golf Australia will develop and implement a risk management strategy, which includes a review of existing child protection practices, to determine how child-safe and child-friendly the organisation is and to determine what additional strategies are required to minimise and prevent risk of harm to children because of the action of an employee, volunteer or another child.

#### 6.1.2: Develop Codes of Conduct for Adults and Children

Golf Australia will ensure that the organisation has codes of conduct that specify standards of conduct and care when dealing and interacting with children, particularly those in the organisation's care. The organisation will also implement a code of conduct to address appropriate behaviour between children.

The code(s) of conduct will set out professional boundaries, ethical behaviour and unacceptable behaviour. (See Part B)

#### 6.1.3: Choose Suitable Employees and Volunteers

Golf Australia will ensure that the organisation takes all reasonable steps to ensure that it engages the most suitable and appropriate people to work with children (in prescribed positions).

This may be achieved using a range of screening measures. Such measures will aim to minimise the likelihood of engaging (or retaining) people who are unsuitable to work with children.

Golf Australia will ensure that working with children checks/criminal history assessments are conducted for employees and volunteers working with children, where an assessment is required by law.

If a criminal history report is obtained as part of their screening process, Golf Australia will ensure that the criminal history information is dealt with in accordance with relevant state requirements. (See Part C)

#### 6.1.4: Support, Train, Supervise and Enhance Performance

Golf Australia will ensure that volunteers and employees who work with children or their records have ongoing supervision, support and training such that their performance is developed and enhanced to promote the establishment and maintenance of a child-safe environment.

## 6.1.5: Empower and Promote the Participation of Children In Decision-Making And Service Development

Golf Australia will promote the involvement and participation of children and young people in developing and maintaining child-safe environments.

#### 6.1.6: Report and Respond Appropriately To Suspected Abuse and Neglect

Golf Australia will ensure that volunteers and employees are able to identify and respond to children at risk of harm.



Golf Australia will make all volunteers and employees aware of their responsibilities under respective state lawsif they have suspicion on reasonable grounds that a child has been or is being abused or neglected. (See Part E)

In addition to any legal obligation, if any person feels another person or organisation bound by this policy is acting inappropriately towards a child or is breaching the code'(s) of practice set out they may make an internal complaint. Please refer to our complaints procedure outlined in

AttachmentD1 of this policy. This will explain what to do about the behaviour and how Golf Australia will deal with the problem.

#### 6.2 Taking Images of Children

Images of children can be used inappropriately or illegally. Golf Australia requires that individuals and associations, wherever possible, obtain permission from a child's parent/guardian before taking an image of a child that is not their own and ensure that the parent knows the way the image will be used. We also require the privacy of others to be respected and disallow the use of camera phones, videos and cameras inside changing areas, showers and toilets.

If Golf Australia uses an image of a child it will avoid naming or identifying the child or it will, wherever possible, avoid using both the first name and surname. We will not display personal information such as residential address, email address or telephone numbers without gaining consent from the parent/guardian. We will not display information about hobbies, likes/dislikes, school, etc as this information can be used as grooming tools by pedophiles or other persons. We will only use appropriate images of a child, relevant to our sport and ensure that the child is suitably clothed in a manner that promotes the sport, displays its successes, etc. Where possible we will seek permission to use these images.

We require our members, member associations and clubs to do likewise.

#### 6.3 Anti-Discrimination and Harassment

Golf Australia opposes all forms of harassment, discrimination and bullying. This includes treating or proposing to treat someone less favourably because of a particular characteristic; imposing or intending to impose an unreasonable requirement, condition or practice which has an unequal or disproportionate effect on people with a particular characteristic; or any behaviour that is offensive, abusive, belittling, intimidating or threatening – whether this is face-to-face, indirectly or via communication technologies such as mobile phone and computers. Some forms of harassment, discrimination and bullying, based on personal characteristics such as those listed in the Dictionary at *[clause 10]*, are against the law.

If any person feels they are being harassed or discriminated against by another person or organisation bound by this policy, please refer to our complaints procedure outlined in attachment D1 of this policy. This will explain what to do about the behaviour and how Golf Australia will deal with the problem.

#### 6.4 Sexual Relationships

Golf Australia takes the view that intimate relationships (whether or not of a sexual nature) between coaches and athletes, while not necessarily constituting harassment, can have harmful effects on the athlete, on other athletes and on the sport's public image. Such relationships may be perceived to be exploitative because there is usually a disparity between coaches and athletes in terms of authority, maturity, status, influence and dependence. Given there is always a risk that the relative power of the coach has been a factor in the development of such relationships, they should be avoided by coaches at all levels. In the event that an athlete attempts to initiate an intimate relationship, the coach must take personal responsibility for discouraging such approaches, explaining the ethical basis for such actions.

The coach or athlete may wish to approach Golf Australia's MPIO or complaints officer or other designated person if they feel harassed. Our complaints procedure is outlined in Attachment [D1] of this policy.



#### 6.5 Pregnancy

Everyone bound by this policy must treat pregnant women with dignity and respect and any unreasonable barriers to participation by them in our sport should be removed. We will not tolerate any discrimination or harassment against pregnant women.

While many sporting activities are safe for pregnant women, there may be particular risks that apply to some women during pregnancy. Those risks will depend on the nature of the sporting activity and the particular pregnant woman's circumstances. Pregnant women should be aware that their own health and wellbeing, and that of their unborn children, should be of utmost importance in their decision making about the way they participate in our sport.

Golf Australia recommends that pregnant women wanting to participate in our sport consult with their medical advisers, make themselves aware of the facts about pregnancy in sport, and ensure that they make informed decisions about participation. We will only require pregnant women to sign a disclaimer if we require other participants to sign one in similar circumstances. We will not require women to undertake a pregnancy test.

#### 6.6 Gender Identity

Everyone bound by this policy must treat people who identify as transgender fairly and with dignity and respect. This includes acting with sensitivity and respect where a person is undergoing gender transition. We will not tolerate any unlawful discrimination or harassment of a person who identifies as transgender or transsexual or who is thought to be transgender. Descriptions of the types of behaviour which could be regarded as transgender discrimination or harassment are provided in the Dictionary at [clause 10].

Golf Australiarecognises that the exclusion of transgender people from participation in sporting events and activities has significant implications for their health, well-being and involvement in community life. In general Golf Australia will facilitate transgender persons participating in our sport with the gender with which they identify.

Golf Australia also recognises there is debate over whether a male to female transgender person obtains any physical advantage over other female participants. This debate is reflected in the divergent discrimination laws across the country. If issues of performance advantage arise, Golf Australia will seek advice on the application of those laws in the particular circumstances.

Golf Australia has its own Gender Policy for male to female transgendered persons only. The Gender Policy is available on the website.

Drug testing procedures and prohibitions also apply to people who identify as transgender. A person receiving treatment involving a Prohibited Substance or Method, as described on the World Anti-Doping Agency's Prohibited List, should apply for a standard Therapeutic Use Exemption.

#### 6.7 Alcohol Policy

Golf Australia recommends that State Associations and their member Clubs adhere to strict guidelines regarding the responsible consumption of alcohol. Generally, alcohol should not be available nor be consumed at a sporting event at which children under 18 are participants in the sport. Responsible service and consumption of alcohol should apply to any alcohol to be consumed after the competition has concluded, including light alcohol and soft drinks always being available; wherever possible, food being available to be consumed when alcohol is available; transport policies, and Board/Committee Members being in attendance to ensure appropriate practices are followed.

#### 6.8 Smoking Policy



The following policies should be applied to sporting and social events:

- No smoking should occur in the vicinity of Under 18 persons. This policy shall apply to coaches, players, trainers, officials and volunteers;
- Social functions shall be smoke free, with smoking permitted at designated outdoor smoking areas;
- Coaches, officials, trainers, volunteers and players will refrain from smoking in the immediate playing area and in the Club House while involved in an official capacity for any of Golf Australia, State Association, Club or representative team, on and off the field.

#### 6.9 Cyber Bullying/Safety

Bullying and harassment in all forms is regarded by Golf Australia as unacceptable in this sport. Given the emergence of new telephone and internet social networks, the opportunity for unwanted and improper comments and statements has dramatically increased. Messages or statements made in these ways using these means of communication are largely instantaneous, and can easily be abused. Others may also manipulate a person by encouraging a statement to be made on twitter or facebook, for example, when the writer may be upset or vulnerable. Bullying has the potential to cause great anxiety and distress to the person who has been the target of any comments or statements. In some cases, bullying is regarded as a criminal offence punishable by imprisonment, amongst other things. Frustration at a referee, team-mate, coach, or sporting body should never be communicated on social network channels, but rather by way of reasoned and logical verbal and written statements and where appropriate, complaints, to the relevant controlling club, league or peak sporting body.

#### 6.10 Social Networking Websites Policy

Golf Australia acknowledges the emergence of new technology and communication mediums (new media), and wishes to enable such new media to be used to benefit the sport and its participants, and to applaud achievements. This can occur due to the immediate nature of communication to a wise audience using channels such as facebook, twitter, and SMS. However, participants within the sport need to be very mindful of a few key matters that could lead to inappropriate use of new media, at times unintended, and at other times without a proper understanding that once comments are made or published, they are in public for a long time, and hard to take back (retract). Cautions:Golf Australia recommends:

- Do not include personal information of yourself or others in social media channels;
- Do not use offensive, provocative or hateful language;
- Use your best judgment do not publish something that makes you the slightest bit uncomfortable, and never write/publish if you are feeling emotional or upset (or are intoxicated)
- Always ask for a person's permission before posting their picture on a social networking forum:
- Never comment on rumours, do not deny or affirm them or speculate about rumours; and
- Always use social network forums to add value and promote the sport in a positive way.

#### 7. Complaints Procedures

#### 7.1 Complaints

Golf Australia aims to provide a simple procedure for complaints based on the principles of procedural fairness (natural justice). Any person (a complainant) may report a complaint about a person/s or organisation bound by this policy (respondent). Such complaints should be reported to the CEO of Golf Australia or the respective Affiliate Member or the respective Affiliate Member Clubs.

The lowest level at which a matter can be dealt with shall always be preferred. Therefore, if a complaint relates to behaviour or an incident that occurred at the:



- state level or involves people operating at the state level, then the complaint should be reported to and handled by the relevant state association in the first instance; or
- Club level or involves people operating at the club level, then the complaint should be reported to and handled by the relevant club in the first instance.

Only matters that relate to or occur at the national level and the most serious cases from club and state level should be referred to the national body.

A complaint may be dealt with informally or formally. The complainant usually decides this unless the CEO of Golf Australia or the respective Affiliate Member or the respective Affiliate Member Clubs considers that the complaint falls outside this policy and would be better dealt with another way and/or the law requires the complaint/allegation to be reported to an appropriate authority.

All complaints will be dealt with promptly, seriously, sensitively and confidentially. Our complaint procedures are outlined in attachment D1.

Individuals and organisations may also pursue their complaint externally under anti-discrimination, child protection, criminal or other relevant legislation.

#### 7.2 Improper Complaints & Victimisation

Golf Australia aims for our complaints procedure to have integrity and be free of unfair repercussions or victimisation against the person making the complaint. If at any point in the complaints process the CEO of Golf Australia or the respective Affiliate Member or the respective Affiliate Member Clubsconsiders that a complainant has **knowingly** made an untrue complaint or the complaint is malicious or intended to cause distress to the person complained of, the matter may be referred to Golf Australia or for appropriate action which may include disciplinary action against the complainant.

Golf Australia will take all necessary steps to make sure that people involved in a complaint are not victimised. Disciplinary measures can be imposed on anyone who harasses or victimises another person for making a complaint.

#### 7.3 Mediation

Golf Australia aims to resolve complaints with a minimum of fuss. Complaints may be resolved by agreement between the people involved with no need for disciplinary action. Mediation allows those involved to be heard and to come up with mutually agreed solutions.

Mediation may occur before or after the investigation of a complaint. If a complainant wishes to resolve the complaint with the help of a mediator, the CEO of Golf Australia or the respective Affiliate Member or the respective Affiliate Member Clubs will, in consultation with the complainant, arrange for a neutral third party mediator where possible. Lawyers are not able to negotiate on behalf of the complainant and/or the respondent. More information on the mediation process is outlined in attachment D2.

#### 7.4 Disciplinary Committees

A Committee may be convened to hear a formal complaint:

- · referred to it by the CEO of Golf Australia;
- referred to it or escalated by a Member Association because of the serious nature of the complaint or inability to be resolved at the state level; and/or
- for an alleged breach of this policy.

Our Disciplinary Committee procedure is outlined in attachmentD5.

A respondent may lodge an appeal only to the Appeal Tribunal in respect of a Committee decision. The decision of the Appeal Tribunal is final and binding on the people involved. Our appeals process is outlined in attachment D5.

Every organisation bound by this policy will recognise and enforce any decision of a Disciplinary Committee or Appeal Tribunal under this policy.



#### 8. What is a Breach of this policy

It is a breach of this policy for any person or organisation to which this policy applies, to do anything contrary to this policy, including but not limited to:

- 8.1 Breaching the Codes of Behaviour (attachment B to this policy);
- 8.2 Bringing the sport and/or Golf Australia into disrepute, or acting in a manner likely to bring the sport and/or Golf Australia into disrepute;
- 8.3 Failing to follow Golf Australia policies (including this policy) and procedures for the protection, safety and welfare of children:
- 8.4 Discriminating against, harassing or bullying (including cyber bullying) any person;
- 8.5 Victimising another person for reporting a complaint;
- 8.6 Engaging in a sexually inappropriate relationship with a person that they supervise, or have influence, authority or power over;
- 8.7 Verbally or physically assaulting another person, intimidating another person or creating a hostile environment within the sport;
- 8.8 Disclosing to any unauthorised person or organisation any Golf Australia information that is of a private, confidential or privileged nature;
- 8.9 Making a complaint they **knew** to be untrue, vexatious, malicious or improper;
- 8.10 Failing to comply with a penalty imposed after a finding that the individual or organisation has breached this policy; or
- 8.11 Failing to comply with a direction given to the individual or organisation during the discipline process.

#### 9. Disciplinary Measures

If an individual or organisation to which this policy applies breaches this policy, one or more forms of discipline may be imposed. Any disciplinary measure imposed under this policy must:

- Be applied consistent with any contractual and employment rules and requirements;
- Be fair and reasonable:
- Be based on the evidence and information presented and the seriousness of the breach; and
- Be determined in accordance with our Constitution, By Laws, this policy and/or Rules of the sport.

#### 9.1 Individual

Subject to contractual and employment requirements, if a finding is made by a Committee that an individual has breached this policy, one or more of the following forms of discipline may be imposed:

- 9.1.1 A direction that the individual make a verbal and/or written apology;
- 9.1.2 A written warning:
- 9.1.3 A direction that the individual attend counselling to address their behaviour;
- 9.1.4 A withdrawal of any awards, scholarships, placing, records, achievements bestowed in any tournaments, activities or events held or sanctioned by Golf Australia;
- 9.1.5 A demotion or transfer of the individual to another location, role or activity;
- 9.1.6 A suspension of the individual's membership or participation or engagement in a role or activity:
- 9.1.7 Termination of the individual's membership, appointment or engagement;
- 9.1.8 A recommendation that Golf Australia terminate the individual's membership, appointment or engagement;
- 9.1.9 In the case of a coach or official, a direction that the relevant organisation de-register the accreditation of the coach or official for a period of time or permanently;
- 9.1.10 A fine:
- 9.1.11 Any other form of discipline that the Committee considers appropriate.

#### 9.2 Organisation

If a finding is made that a Member Association or Associated Club has breached its own or this national Member Protection Policy, one or more of the following forms of discipline may be imposed by the relevant Tribunal:



- 9.2.1 A written warning;
- 9.2.2 A fine:
- 9.2.3 A direction that any rights, privileges and benefits provided to that organisation by the national body or other peak association be suspended for a specified period;
- 9.2.4 A direction that any funding granted or given to it by Golf Australiacease from a specified date:
- 9.2.5 A direction that Golf Australia cease to sanction events held by or under the auspices of that organisation;
- 9.2.6 A recommendation to Golf Australia that its membership of Golf Australia be suspended or terminated in accordance with the relevant constitution or rules; and/or
- 9.2.7 Any other form of discipline that the national body or peak organisation considers to be reasonable and appropriate.

#### 9.3 Factors to consider

The form of discipline to be imposed on an individual or organisation will depend on factors such as:

- Nature and seriousness of the breach;
- If the person knew or should have known that the behaviour was a breach;
- · Level of contrition;
- The effect of the proposed disciplinary measures on the person including any personal, professional or financial consequences;
- If there have been relevant prior warnings or disciplinary action;
- Ability to enforce discipline if the person is a parent or spectator (even if they are bound by the
  policy); and/or
- Any other mitigating circumstances.

#### 10. Dictionary

This Dictionary sets out the meaning of words used in this policy and its attachments without limiting the ordinary and natural meaning of the words. State/Territory specific definitions and more detail on some of the words in this dictionary can be sourced from the relevant State/Territory child protection commissions or equal opportunity and anti-discrimination commissions.

**Abuse** is a form of harassment and includes physical abuse, emotional abuse, sexual abuse, neglect, and abuse of power. Examples of abusive behaviour include bullying, humiliation, verbal abuse and insults.

**Affiliated Member** means those states, territories and other organisations affiliated with Golf Australia. **Affiliate Member Clubs** means those clubs affiliated with Golf Australia's Affiliated Members.

Child means a person who is under the age of 18 years

**Child abuse** involves conduct which puts children at risk of harm (usually by adults, sometimes by other children) and often by those they know and trust. It can take many forms, including verbal and physical actions and by people failing to provide them with basic care. Child abuse may include:

- Physical abuse by hurting a child or a child's development (e.g. hitting, shaking or other physical harm; giving a child alcohol or drugs; or training that exceeds the child's development or maturity).
- Sexual abuse by adults or other children where a child is encouraged or forced to watch or
  engage in sexual activity or where a child is subject to any other inappropriate conduct of a
  sexual nature (e.g. sexual intercourse, masturbation, oral sex, pornography including child
  pornography or inappropriate touching or conversations).
- Emotional abuse by ill-treating a child (e.g. humiliation, taunting, sarcasm, yelling, negative criticism, name calling, ignoring or placing unrealistic expectations on a child).
- Neglect (e.g. failing to give food, water, shelter or clothing or to protect a child from danger or foreseeable risk of harm or injury).

Complaint means a complaint made under clauseD of this policy.



Complainant means a person making a complaint.

**Complaint Handler/Manager** means a person appointed under this policy to investigate a Complaint

**Discrimination** means treating or proposing to treat someone less favourably because of a particular characteristic in the same or similar circumstances in certain areas of public life (Direct Discrimination), or imposing or intending to impose an unreasonable requirement, condition or practice that is the same for everyone, but which has an unequal or disproportionate effect on individuals or groups with particular characteristics (Indirect Discrimination). The characteristics covered by discrimination law across Australia includes:

- Age;
- · Disability;
- Family/carer responsibilities;
- Gender identity/transgender status;
- Homosexuality and sexual orientation;
- · Irrelevant medical record:
- Irrelevant criminal record;
- · Political belief/activity;
- Pregnancy and breastfeeding;
- Race;
- Religious belief/activity;
- Sex or gender;
- Social origin;
- · Trade union membership/activity.

(Some States and Territories include additional characteristics such as physical features or association with a person with one or more of the characteristics listed above).

#### **Examples of Discrimination**

- Age: A club refuses to allow an older person to coach a team simply because of age.
- **Breastfeeding:** A member of the club who is breastfeeding a baby in the club rooms is asked to leave.
- Disability: A player is overlooked for team selection because of mild epilepsy.
- **Family responsibilities:** A club decides not to promote an employee because he has a child with a disability even though the employee is the best person for the job.
- **Gender Identity:** A transgender player is harassed when other players refuse to call her by her female name.
- Homosexuality: An athlete is ostracised from her team after it becomes known that she is a lesbian.
- Marital Status: A player is deliberately excluded from team activities and social functions because she is single
- **Pregnancy:** A woman is dropped from a squad when she becomes pregnant.
- Race: An Italian referee is not permitted to referee games with a high proportion of Italian players on one team because of his race.
- Sex: Specialist coaching is only offered to male players in a mixed team.

**Harassment** is any type of behaviour that the other person does not want and that is offensive, abusive, belittling or threatening. The behaviour is unwelcome and a reasonable person would recognise it as being unwelcome and likely to cause the recipient to feel offended, humiliated or intimidated.

Unlawful harassment is sexual or targets a person because of their race, sex, pregnancy, marital status, sexual orientation or some other personal characteristic protected by law (see characteristic list under discrimination).

It does not matter whether the harassment was intended: the focus is on the impact of the behaviour. The basic rule is if someone else finds it harassing then it could be harassment.



Harassment may be a single incident but is usually repeated. It may be explicit or implicit, verbal or non-verbal, and includes electronic cyber communication.

Discrimination and harassment are not permitted in employment (including volunteer and unpaid employment); when providing sporting goods and services including access to sporting facilities; when providing education and accommodation; the selection or otherwise of any person for competition or a team (domestic or international); the entry or otherwise of any player or other person to any competition and the obtaining or retaining membership of clubs and organisations (including the rights and privileges of membership).

Some exceptions to state and federal anti-discrimination law apply. Examples include:

- holding a competitive sporting activity for boys and girls only who are under 12 years of age
  or of any age where strength, stamina or physique is relevant or
- not selecting a participant if the person's disability means he or she is not reasonably capable of performing the actions reasonably required for that particular sporting activity.

Requesting, assisting, instructing, inducing or encouraging another person to engage in discrimination or harassment may also be against the law.

It is also a breach of discrimination law to victimise a person who is involved in making a complaint of discrimination or harassment. Example: a player is ostracised by her male coach for complaining about his sexist behaviour or for supporting another player who has made such a complaint.

Public acts of racial hatred which are reasonably likely to offend, insult, humiliate or intimidate are also prohibited. This applies to spectators, participants or any other person who engages in such an act in public. Some states and territories also prohibit public acts that vilify on other grounds such as homosexuality, gender identity, HIV/AIDS, religion and disability – see vilification.

**Mediator** means an impartial/neutral person appointed to mediate Complaints.

**Member protection** is a term used by the Australian sport industry to describe the practices and procedures that protect members – both individual members such as players, coaches and officials, and the member organisations such as clubs, state associations, other affiliated associations and the national body. Member protection involves:

- protecting those that are involved in sport activities from harassment, abuse, discrimination and other forms of inappropriate behaviour
- adopting appropriate measures to ensure the right people are involved in an organisation, particularly in relation to those involved with juniors, and
- providing education.

**Member Protection Information Officer** (MPIO) means a person trained to be the first point of contact for a person reporting a complaint under, or a breach of, this policy. The MPIO provides confidential information and moral support to the person with the concern or who is alleging harassment or a breach of this policy. They help the complainant deal with any emotions they may have about what has happened and operate as a sounding board as the complainant decides what they want to do. The MPIO may accompany the complainant in anything they decide to do, if it feels appropriate and they are happy to do it.

Each Member Association and Club should have a MPIO.

Natural justice (also referred to as procedural fairness) incorporates the followingprinciples:

- both the Complainant and the Respondent must know the full details of what is being said against them and have the opportunity to respond;
- · all relevant submissions must be considered;
- no person may judge their own case;
- · the decision maker/s must be unbiased, fair and just;
- the penalties imposed must be fair.

**Police check** means a national criminal history record check conducted as a pre-employment, pre-engagement or current employment background check on a person.

Policy, policy and this policy means this Member Protection Policy.

Respondent means the person who is being complained about.



Role-specific codes of conduct (or behaviour) means standards of conduct required of certain roles (e.g. coaches).

**Sexual harassment** means unwanted, unwelcome or uninvited behaviour of a sexual nature which could reasonably be anticipated to make a person feel humiliated, intimidated or offended. Sexual harassment can take many different forms and may include unwanted physical contact, verbal comments, jokes, propositions, display of pornographic or offensive material or other behaviour that creates a sexually hostile environment.

Sexual harassment is not behaviour based on mutual attraction, friendship and respect. If the interaction is between consenting adults, it is not sexual harassment.

**Sexual offence** means a criminal offence involving sexual activity or acts of indecency including but not limited to (due to differences under state/territory legislation):

- Rape
- Indecent assault
- · Sexual assault
- · Assault with intent to have sexual intercourse
- Incest
- Sexual penetration of child under the age of 16
- · Indecent act with child under the age of 16
- Sexual relationship with child under the age of 16
- Sexual offences against people with impaired mental functioning
- · Abduction and detention
- Procuring sexual penetration by threats or fraud
- · Procuring sexual penetration of child under the age of 16
- Bestiality
- · Soliciting acts of sexual penetration or indecent acts
- · Promoting or engaging in acts of child prostitution
- · Obtaining benefits from child prostitution
- · Possession of child pornography
- · Publishing child pornography and indecent articles.

**Transgender** is a general term applied to individuals and behaviours that differ from the gender role commonly, but not always, assigned at birth. It does not imply any specific form of sexual orientation.

**Victimisation** means subjecting a person or threatening to subject a person to any detriment or unfair treatment because that person has or intends to pursue their rights to make any complaint including a complaint under government legislation (e.g. anti-discrimination) or under this Policy, or for supporting such a person.

**Vilification** involves a person or organisation doing public acts to incite hatred towards, serious contempt for, or severe ridicule of a person or group of persons having any of the attributes or characteristics within the meaning of discrimination. Public acts that may amount to vilification include any form of communication to the public and any conduct observable by the public.

Young People/Person means people in the 13-18 year age group.



#### PART B:ROLE-SPECIFIC CODES OF CONDUCT

#### Attachment B1: Player/Caddie Code of Conduct

This Code of Conduct applies to amateur golfers and caddies, in all Championships, major activities, events and competitions conducted by GA or its Member Associations in addition to any other requirements of Players and Caddies as set out in tournament conditions, local rules or by-laws of clubs hosting GA events. NB. Parents/Guardians are subject to the Code of Conduct in Attachment B5.

Each Player or Caddie in a competition must adhere to commonly-accepted standards of golfing etiquette and sportsmanship.

In order to ensure proper standards of behaviour during a competition a Player or Caddie, who commits an offence under this Code will face disciplinary proceedings.

#### 1 DEFINITIONS

In this code, unless the context otherwise requires:

Term	Definition
Appeal Tribunal	means the tribunal referred to in attachment D
Board	means the board of directors of GA
Caddie	means the definition as per the Rules of Golf
Code	means this Code of Conduct
Competition	means a Championship, event, competition, practice session or major activity conducted or sanctioned by GA
Conduct Officers	means two officials of GA appointed at any time to consider, hear and determine a report during or after the conclusion of a competition
GA	means Golf Australia Limited
Investigative Officer	means a person appointed by GA to administer a report
National Squad	means the squad by that name comprising a number (determined from time to time by the Board) of Australia's best male and female amateur players
Notice	means notice in writing by letter, facsimile, other written means of communication, or email
Player	means a player or participant in a competition.
Report	means any oral or written statement by any person of an alleged offence by a player under this Code

An act is deemed to occur "during a competition" if it occurs:

- a) when travelling to or from a competition;
- b) on any qualifying or practice day for a competition;
- when playing at a specific course for the purpose of practicing for an upcoming event at that course; or
- d) on any day during which the competition is conducted.

#### 2 OFFENCES

NOTE: The use of any narcotic or other substance may constitute an offence under the Doping Policy of GA.

- 2.1 A Player or Caddie is guilty of a Category A offence under this Code if the Player or Caddie:
  - a) physically attacks or abuses, in any way, a player, an official, or person during a competition;
  - b) verbally threatens a player, an official, or person during a competition;
  - c) racially vilifies a player, an official, or person during a competition;
  - d) wrongfully damages the facilities, including the course and the clubhouse, of the competition golf course;



- e) wrongfully removes or damages property belonging to another player, an official, the tournament organiser, or the competition golf club;
- f) deliberately breaks a Rule (as defined in the Rules of Golf);
- g) deliberately returns a false score card;
- h) during a competition, deliberately seeks to manipulate the player's Australian handicap;
- i) fails or refuses to co-operate with, or obstructs, any investigation by the Investigative Officer of the Player or Caddie's conduct or the conduct of another person:
- j) fails or refuses to co-operate with, or obstructs, a hearing by the Conduct Officers or the Appeal Tribunal;
- k) behaves in a manner detrimental to the good name and reputation of GA; or
- I) brings the game of golf into disrepute.
- 2.2 A Player or Caddie is guilty of a Category B offence under this Code if the Player or Caddie:
  - a) in relation to a competition, publicly criticises:
    - i. the competition golf course;
    - ii. the competition itself;
    - iii. the organisers of the competition;
    - iv. the sponsors of the competition; or
    - v. any official supervising or organising the competition during a competition;
  - throws or deliberately or in anger breaks golf equipment (including golf balls) during a competition;
  - uses abusive or profane language towards another player, an official, or person during a competition;
  - d) utters audible obscenities during a competition;
  - e) consumes any alcohol or a prohibited substance under the GA Doping Policy during the course of any round played in a competition;
  - f) is unable to play golf to the best of their ability without just cause; or
  - g) behaves in a manner detrimental to the performance of other players.
- 2.3 A Player or Caddie is guilty of a Category C offence if the Player or Caddie:
  - a) fails to comply with the Rules of Golf as amended by Local Rules in force at any competition, or fails to comply with any other rules, by-laws, directions or instructions, including dress regulations, as specified by GA or the Championship Play Committee for that competition or any other duly authorised official:
  - b) fails to comply with the Rules of Golf with respect to Section I Etiquette. NB Etiquette includes the continual failure to fill in divots or repair pitch marks;
  - c) continually fails to play without undue delay;
  - d) commits an act to deliberately disqualify the player from a competition or, during the course of a round picks up the player's own ball without playing out a hole;
  - e) misses a tee time or withdraws from a competition before the completion of that competition without providing good reason in writing for doing so:
  - f) uses a radio (of any kind), recorder or mobile telephone during the course of play in a competition or allows the player's caddy to do so;
  - g) fails, without good reason, to attend the trophy presentation at the completion of a competition where the player is:
    - i. in the case of a stroke play event, a trophy winner; or
    - ii. in the case of a match play event, a finalist or semi-finalist.
- 2.4 If a Player or Caddie commits two or more Category C offences during a competition, the Player or Caddie is deemed to have committed a Category B offence and is subject to penalties prescribed for a Category B offence. If a Player or Caddie commits two or more Category B offences during a competition, the Player or Caddie is deemed to have committed a Category A offence and is subject to penalties prescribed for a Category A offence.
- 2.5 Subsequent breaches of the Code within a 24 month period will result in a penalty prescribed for the Category one above the highest Category of the previous breach. For sake of clarity, should a Player or Caddie commit a Category B offence originally, and then commit a Category B offence 6 months later, the player is deemed to have committed a Category A offence and is subject to penalties



prescribed for a Category A offence. Should the original breach be a Category A offence, the penalty imposed will be as the Conduct Officers see fit.

#### 3 DISCIPLINARY PROCEDURE

- 3.1 Any report made to GA or the Championship Play Committee during a competition or after the conclusion of the competition must be referred to an Investigative Officer and the Conduct Officers.
- 3.2 Upon receiving a report under clause 3.1, the Conduct Officers must determine whether:
  - a) no further action should be taken; or
  - b) if in the course of such investigation it is evident that, in the opinion of the Conduct Officers, a breach has occurred, an appropriate penalty may be imposed, and communicated to the Player or Caddie by GA (Notice).
- 3.3 The appeal procedure for determination of breach by a Player or Caddie is outlined in attachment D.

#### 4 PENALTIES

- 4.1 If a Player or Caddie is found guilty of a Category A offence, any of the following penalties, minimum 3 months and not normally exceeding more than 2 years duration, may be imposed:
  - a) disqualify the player from the competition;
  - b) an order that the player attend appropriate counseling sessions as specified by GA;
  - a recommendation to the player's home club that the player's membership be suspended for a set period of time;
  - d) a recommendation to the player's State Association that the player not be permitted to enter State Events:
  - e) a recommendation to the player's State Association that the player be suspended from a State Squad:
  - f) suspension of the player's Australian Handicap;
  - g) suspension from the National Squad;
  - h) in the case of an offence under clauses 2.1(d) or (e) of this Code, an order that the player should pay compensation to the player, official, tournament organiser or club who suffered loss as a result of the accused player's conduct, or
  - i) such other penalty as determined from time to time.
- 4.2 If a Player or Caddie is found guilty of a Category B offence, any of the following penalties, minimum 1 month but not more than 3 months for any one offence, may be imposed:
  - a) disqualify the player from the competition;
  - b) an order that the player attend appropriate counselling sessions as specified by GA;
  - a recommendation to the player's home club that the player's membership be suspended for a set period of time;
  - d) a recommendation to the player's State Association that the player not be permitted to enter State Events:
  - e) a recommendation to the player's State Association that the player be suspended from a State Squad;
  - f) a penalty under the Doping Policy of GA (if applicable);
  - g) suspension of the player's Australian Handicap;
  - h) suspension from the National Squad; or
  - i) such other penalty as determined from time to time.
- 4.3 If a Player or Caddie is found guilty of a Category C offence, any of the following penalties may be imposed:
  - a) a severe reprimand;
  - b) an order that the player attend appropriate counselling sessions as specified by GA; or
  - c) suspension of the player's Australian Handicap (recommendation: no more than 1 month);
  - d) such other penalty as determined from to time.



#### 5 CENTRAL REGISTER

- 5.1 GA will retain a record of all breaches that have been found against a Player, the results of any appeals from such findings and any pending appeals.
- 5.2 Where a Player commits a breach, GA must forward a copy of the Notice and notice of any appeals in relation to the breach to the Player's Home State Association and Home Club which must be kept on register.
- 5.3 A breach is only to be kept on a Player's record for a period of 24 months from the date such breach was committed or, in the case where the breach is the subject of an appeal, from the date the appeal is upheld.
- 5.4 GA will comply with the Privacy Act 1988 (Cth) when collecting or receiving information under this Code



#### Attachment B2: Coach Code of Conduct

In addition to Golf Australia's General Code of Behaviour, you must meet the following requirements in regard to your conduct during any activity held or sanctioned by Golf Australia, a member association or an affiliated club and in your role as a coach appointed by Golf Australia, a member association or an affiliated club:

- 1. Do not tolerate acts of aggression.
- 2. Provide feedback to players and other participants in a manner sensitive to their needs. Avoid overly negative feedback and enforce that coming first is not always the priority.
- 3. Recognise players' rights to consult with other coaches and advisers. Cooperate fully with other specialists (for example, sports scientists, doctors and physiotherapists).
- 4. Treat all players fairly within the context of their sporting activities, regardless of gender, race, place of origin, athletic potential, colour, sexual orientation, religion, political beliefs, socioeconomic status and other conditions.
- 5. Encourage and facilitate players' independence and responsibility for their own behaviour, performance, decisions and actions.
- 6. Involve the players in decisions that affect them.
- 7. Encourage players to respect one another and to expect respect for their worth as individuals regardless of their level of play.
- 8. Ensure that the tasks and/or training set are suitable for age, experience, ability, and physical and psychological conditions of the players.
- 9. Ensure any physical contact with players is appropriate to the situation and necessary for the player's skill development.
- 10. Be acutely aware of the power that you as a coach develop with your players in the coaching relationship and avoid any sexual intimacy with players that could develop as a result.
- 11. Avoid situations with your players that could be construed as compromising.
- 12. Actively discourage the use of performance enhancing drugs, and the use of illegal substances.
- 13. Actively discourage the regular use of alcohol and tobacco.
- 14. Abide by the relevant Child Protection Requirements and Legislation in the State you perform your duties.
- 15. Do not exploit any coaching relationship to further personal, political or business interests at the expense of the best interest of your players.
- 16. Accept and respect the role of officials in ensuring that competitions are conducted fairly and according to established rules.
- 17. Know and abide by rules, regulations and standards, and encourage players to do likewise. Accept both the letter and the spirit of the rules.
- 18. Be honest and ensure that qualifications are not misrepresented.



#### Attachment B3: Member Code of Conduct

In addition to Golf Australia's General Code of Behaviour, you must meet the following requirements in regard to your conduct during any activity held or sanctioned by Golf Australia, a member association or an affiliated club and in your role as an official appointed by Golf Australia, a member association or an affiliated club:

- 1. Place the safety and welfare of the players/participants above all else.
- 2. Accept responsibility for all actions taken.
- 3. Be impartial.
- 4. Avoid any situation which may lead to a conflict of interest.
- 5. Be courteous, respectful and open to discussion and interaction.
- 6. Value the individual in sport.
- 7. Abide by the relevant Child Protection Requirements and Legislation in the State you perform your duties.



#### Attachment B4: Administrator (Volunteer) Code of Conduct

In addition to Golf Australia's General Code of Behaviour, you must meet the following requirements in regard to your conduct during any activity held by or under the auspices of Golf Australia, a member association or an affiliated club and in your role as an administrator of Golf Australia, a member association or an affiliated club:

- 1. Resolve conflicts fairly and promptly through established procedures.
- 2. Maintain strict impartiality.
- 3. Be aware of your legal responsibilities.
- 4. Abide by the relevant Child Protection Requirements and Legislation in the State you perform your duties.
- 5. Act honestly, in good faith and in the best interests of the sport as a whole.
- 6. Ensure that any information acquired or advantage gained from the position is not used improperly.
- 7. Help coaches and officials highlight appropriate behavior and skill development, and help improve the standards of coaching and officiating.



#### Attachment B5: Parent/Guardian Code of Conduct

As a parent/guardian of a player/participant in any activity held by or under the auspices of Golf Australia, a member association or an affiliated club, you must meet the following requirements in regard to your conduct during any such activity or event:

- 1. Respect the rights, dignity and worth of others.
- 2. Remember that your child participates in sport for their own enjoyment, not yours. Do not pressure them.
- 3. Focus on your child's efforts and performance rather than winning or losing.
- 4. Never ridicule or yell at your child and other children for making a mistake or losing a competition.
- 5. Show appreciation for good performance and skilful plays by all players (including opposing players).
- 6. Demonstrate a high degree of individual responsibility especially when dealing with or in the vicinity of persons under 18 years of age, as your words and actions are an example.
- 7. Respect officials' decisions and teach children to do likewise.
- 8. Do not physically or verbally abuse or harass anyone associated with the sport (player, coach, umpire and so on).
- 9. Respect the rights, dignity and worth of every young person regardless of their gender, ability, cultural background or religion.
- 10. Be a positive role model.
- 11. Understand the repercussions if you breach, or are aware of any breaches of, this code of behaviour.
- 12. Respect officials' decisions and teach children to do likewise.



#### **Attachment B6: Spectator Code of Conduct**

As a spectator of an activity held by or under the auspices of Golf Australia, a member association or an affiliated club, you must meet the following requirements in regard to your conduct during any such activity or event:

- Respect the performances and efforts of all people
- Reject the use of violence in any form, whether it is by spectators, coaches, officials or athletes.
- Respect the decisions of officials and administrators.
- Do not use foul language, sledge or harass players, coaches or officials.



## PART C: SCREENING / WORKING WITH CHILDREN CHECK REQUIREMENTS

#### **Background**

Child protection is about keeping children safe from harm/abuse. Child abuse is illegal, and all states and territories have their own systems and laws that cover screening and/or the reporting and investigation of cases of child abuse.

Working with Children Check (WWCC) laws aim to prevent people who pose a risk from working with children as paid employees or volunteers. In New South Wales, Queensland, Western Australia, Victoria Northern Territory and South Australian laws require individuals involved in areas such as sport and recreation to undertake a check to determine their suitability to work (in a paid or volunteer capacity) with children. This is done by checking certain criminal history and other matters. In some states this also involves reviewing relevant findings from disciplinary proceedings. There are also requirements placed on organisations.

The Australian Capital Territory and Tasmania are currently reviewing their screening laws. New requirements and amendments will be added to this policy as they are introduced. There is no current screening process or formal legislation, however, individual employers or sporting organisations may require police checks at their discretion.

Please be aware that state and territory WWCC requirements may also apply to individuals who visit states with screening laws. For example, if a state association or club takes players U18 into New South Wales for training camps, competition or other activities, those travelling with the teams must comply with NSW law.

The state WWCC requirements apply regardless of our national, state or club Member Protection Policy.

The following attachments provide:

- summary information on state and territory WWCC requirements and where to obtain more information and relevant forms
- our Member Protection Declaration (for all states/territories except NSW who must complete a Prohibited Employment Declaration provided by the NSW Commission for Children and Young People)
- our screening requirements for people residing in ACT and Tasmania



#### **Attachment C1: SCREENING REQUIREMENTS**

(for states/territories without Working With Children Checks such as ACT and Tasmania.)

This attachment sets out the screening process for people in Golf Australia or Affiliated Member or Affiliated Member Club who work (paid or voluntary), coach, supervise or have regular unsupervised contact with people under the age of 18 years.

Golf Australia will, and also requires state associations and clubs to:

- 1. Identify positions that involve working, coaching, supervising or regular unsupervised contact with people under the age of 18 years.
- 2. Obtain a completed *Member Protection Declaration (MPD)* (Attachment C2) from all people who are identified in the above step and keep it in a secure place.
- 3. Provide an opportunity for a person to give an explanation if a MPD isn't provided or it reveals that the person doesn't satisfactorily meet any of the clauses in the MPD. We will then make an assessment as to whether the person may be unsuitable to work with people under the age of 18 years. If not satisfied we will not appoint them to the role/position.
- 4. Where possible, check a person's referees (verbal or written) about his/her suitability for the role.
- 5. Ask the people identified in step 1 to sign a consent form for a national police check.
- 6. Possibly request (or ask the person to request) a national 'Part Exclusion' police check from our relevant police jurisdiction. This check excludes irrelevant records. If the police check indicates a relevant offence, wewill provide an opportunity for the person to give an explanation, and then we will make an assessment as to whether the person may pose a risk to or be unsuitable to work with people under the age of 18 years. If not satisfied we will not appoint them to the role/position.
- 7. Make an assessment as to whether the person may be unsuitable to work with people under the age of 18 years if the person does not agree to a national police check after explaining why it is a requirement under our policy. If unsatisfied, we will not appoint them.
- 8. Decide whether to offer the person the position taking into account the result of the police check and any other information the club has available to it. Where it is not practical to complete the police check prior to the person commencing in the position, we will complete the check as soon as possible, and if necessary, act immediately on the outcome.
- 9. Protect the privacy of any person who is checked and maintain confidentiality of any information obtained through the checking process.
- 10. Return information collected during screening (such as a completed MPD form, police records and referee reports) to the relevant person if that person is not appointed to the position, or otherwise be destroyed within 28 days of the date of the decision or the expiry of any appeal period, unless within that time the person requests that the documents be returned to them. For appointed persons, information will be kept on file in a secure location.



#### **Attachment C2: MEMBER PROTECTION DECLARATION**

Golf Australia has a duty of care to all those associated with the sport and to the individuals and organisations to whom our Member Protection Policy applies. As a requirement of our Member Protection Policy, Golf Australia must enquire into the background of those who undertake any work, coaching or regular unsupervised contact with people under the age of 18 years.

#### Attachment C3: STATE/TERRITORY CHILD PROTECTION REQUIREMENTS

The following information was updated in May 2011. It is subject to change at any time.

#### 1. QUEENSLAND

A person will need a Working with Children Check (WWCC), also known as a **blue card**, if they propose to work in a paid or voluntary capacity or to carry on a business in a child-related area regulated by the *Commission for Children and Young People and Child Guardian Act 2000*, for at least:

- Eight consecutive days; or
- Once a week for each week during a period of four weeks; or
- Once a fortnight for each fortnight during a period of eight weeks; or
- Once a month for each month during a period of six months.

Once a person is checked and approved, they are issued with a blue card. Volunteers and paid employees employed in sporting organisations generally fall under the 'churches, clubs and associations' category of regulated employment. Volunteers and paid employees employed in private businesses may fall under the 'sport and active recreation' category of regulated employment. The check is a detailed national criminal history check including charges and investigations relating to children.

Police Officers and registered teachers do not need to apply for a blue card when providing child related services that fall outside of their professional duties. They should however apply to the Commission for an exemption card.

People such as those with previous convictions involving children are disqualified from applying for or renewing a blue card (refer to website below for details).

As a result of changes and improvements to the blue card system as at the 1<sup>st</sup> of April, 2011 and 1<sup>st</sup> July, 2011 more people will be screened and have their criminal histories monitored. State Government employees and volunteers who work with Children will now be screened through the Commission. It will be compulsory for employers/organisations to notify the Commission if they employ someone who already holds a blue card.

A blue card remains current for two years. Existing card holders will be notified by the Queensland Commission for Children and Young People and Child Guardian before their card expires. It is important to note that Blue Cards issued for applicants received after 1 April 2010 will now be valid for three years, instead of two. Volunteers who are under 18 years of age do not require a Blue Card; however, employees under 18 years of age do require a blue card. In addition to obligations regarding the blue card, **employers** must develop and implement a written child protection risk management strategy and review it each year.

#### 2. NEW SOUTH WALES

The Commission for Children and Young People Act 1998 (NSW) provides minimum standards for those who work with children. All organisations within NSW that employ people in child-related employment (in a paid or unpaid capacity) must meet the requirements of the Working With Children Check ("WWC Check") Child related employment is defined as work which primarily involves direct unsupervised contact with children. Applicants applying for paid positions need to sign a Background Check Consent Form, and then submit a Background Check Request Form to the approved screening agency for them to conduct the WWC Check. The WWC Check involves two elements:

- 1. Excluding people with convictions for serious sex and violence crimes against children; and
- 2. Background checking for preferred applicants for primary child-related employment, ministers of religion and authorised carers

If you need to do the WWC Check, you will need to register with the appropriate Approved Screening Agency. Approved Screening Agencies are the agencies appointed by the Government to carry out the WWCC. As of the 1<sup>st</sup> of March 2010 the Approved Screening Agency functions at Sport and Recreation were moved to the NSW Commission for Children and Young People.

Sporting organisations are responsible for managing the WWC Check process. Individuals cannot apply for a WWC Check directly. Sporting organisations should register with the **NSW Commission for Children and Young People** providing a contact who will receive the information on the background checks. It is important to note that there are new online WWC Check forms and also clearer online employer guidelines.

Under the relevant NSW Child Protection Legislation all paid and unpaid applicants for child-related employment need to sign a Prohibited Employment Declaration, which confirms that they are not a prohibited person. No one should be employed in child-related employment who refuses to sign the Prohibited Employment Declaration.

Background checks are currently not available for volunteers. Volunteers must certify they are not convicted of serious sex or violence offences that prohibit them from child-related employment. From May 2010, it has been compulsory for self-employed people in child-related employment to hold a certificate which confirms that they are not a prohibited person.

People not eligible for the WWC Checks can apply for a National Police Check through NSW Police (visit:www.police.nsw.gov.au/).

Any relevant employment proceedings should be reported to the Commission for Children and Young People for any paid and unpaid employees. A relevant employment proceeding involves any inappropriate conduct with or in the presence of a child or children.

The Act does not stipulate an age at which WWC Checks become mandatory for employees in child-related employment, so all employees in such settings, including people under 18 years of age, are required to obtain a WWC Check.

A WWC Check is valid for employment in that position within the organisation. Short-term employees (where that person is being employed for periods of less than six months and returning for short periods throughout a 12 month period) only need to be checked **once** every 12 months. People returning from leave into the same child-related employment do not need to be re-checked. Existing employees are only checked if they are recruited to a new position with a different range of child-related contact, within the organisation.

#### 3. WESTERN AUSTRALIA

The Working with Children Check (WWCC) is a compulsory and rigorous criminal record check for certain people who carry out 'child-related work' in Western Australia (WA). The *Working with Children (Criminal Record Checking) Act 2004* (the Act) aims to protect children from harm by providing a high standard of compulsory national criminal record check for people wishing to work in paid or unpaid child-related work or volunteer child-related work in WA.

A person is considered to be working in 'child-related work' if their usual duties and work involves, or is likely to involve contact with a child in connection with specified categories of work (see the website below for further details). It includes child-related work carried out by paid employees, volunteers, unpaid people and the self-employed. Parents volunteering in connection with their child's activity are exempt (although this does not apply to overnight camps); however they should still be required to complete the non-WWC Check screening process. There are other exemptions, for example, volunteers under 18 years of age. Further details about exemptions can be found on the website below. Only those considered to be working in child-related work under the Act may apply.

Applicants will be issued with either:

- An Assessment Notice in the form of a WWC Check Card enabling them to be in all types of childrelated work for three years unless there are new offences of concern.
- An Interim Negative Notice, which prohibits them from child-related work until a final decision is made on their application.
- A Negative Notice, which prohibits them from carrying out child-related work (including voluntary work)

There are set obligations and strong penalties for non-compliance including for employers and volunteer co-coordinators that engage persons who do not possess a valid WWCC Card.

It is an offence for employers, volunteer organisations and education providers to engage in child – related work without a Working with Children Card. It is also an offence for employees, volunteers and students to carry out child-related work without doing so. The Act provides a five day grace period in most cases to provide reasonable flexibility and allow for unforeseen circumstances.

Additionally, WWCC are only concerned with child-related offences, therefore employers may require that employees or volunteers obtain both a WWCC Check and a National Police Check, Information on obtaining a National Police Check can be obtained from the WA police (visit: <a href="www.police.wa.gov.au/">www.police.wa.gov.au/</a>).

#### 4. <u>VICTORIA</u>

The Working with Children Check (WWCC) creates a mandatory minimum checking standard across Victoria. The *Working with Children Act 2005* requires that some people who work or volunteer in child-related work require a WWCC. The WWCC are valid for five years and must be renewed if you intend to continue to undertake 'child-related work' after your WWCC card expires. Should you require a WWCC card, you must apply for a WWCC card by the 30<sup>th</sup> of June 2011.

The check involves a national police records check and a review of relevant findings from prescribed professional disciplinary bodes (currently only the Victorian Institute of Teaching). There is an exemption for volunteers whose own children are involved in the particular activity; however they should still be required to complete the screening process.

A person who has no criminal or professional disciplinary history will be granted an *Assessment Notice*. This notice will entitle the person to undertake child-related work in Victoria and is valid for five years (unless revoked). As of the 1<sup>st</sup> of December, 2010 the *Assessment Notice* became the WWCC Card and not the A4-Style Assessment Notice. Cardholders can now show employers and organisations who employ them in 'child-related work', the card itself, as legal proof that they have passed the Check. A person deemed unsuitable to work or volunteer with children will be given a *negative notice* and cannot work in child-related work in Victoria.

Card holders do not need to apply for a new WWCC when they change their employer or volunteer organisation, unless they are moving from volunteer status to paid work status.

People under 18 years of age do not require a WWCC.

#### 5. SOUTH AUSTRALIA

In South Australia the requirement to conduct criminal history assessments for people working with children is being phased-in over three years.

For recreation and sporting organisations this requirement commences from 1 January 2012 and is to be completed by 31 December 2013.

The obligation to conduct the Criminal History Assessment <u>rests with the organisation providing the</u> <u>service</u>. Organisations who provide services wholly or partly for children in South Australia therefore must comply with this requirement, so must include these requirements in their MPP documentation

Golf SA may conduct a criminal history assessment themselves or apply to a third party (such as the state sporting body for an assessment and letter of clearance).

#### Assessments required for prescribed positions

All staff and volunteers who occupy a prescribed position (as set out under section 8B (8) of the South Australian *Children's Protection Act 1993*) are required to undergo a criminal history assessment once every three years unless an exemption applies. (see below)

Criminal history assessments are also required prior to the appointment of new staff or volunteers to prescribed positions.

This includes all people who regularly work with or around children in an unsupervised capacity or have access to children's records.

#### Procedure for conducting criminal history assessments

Note: The Children's Protection Act 1993 enables organisations to decide the manner in which they will conduct criminal history assessments. Please choose the option below that reflects the method of assessment that your organisation has adopted.

#### **Option 1**

A National Police Check (NPC) from South Australia Police will be required for all persons taking on a role in a prescribed position prior to their appointment and then at three yearly intervals or as requested by the board.

For many volunteers the cost for this application will be covered under the Volunteer Organisation Authorisation number (VOAN) through the governing body/SSO.

South Australia Police require the explicit written consent of the applicant prior to the release of criminal history information. The NPC application form is available from <a href="http://www.police.sa.gov.au/sapol/services/information">http://www.police.sa.gov.au/sapol/services/information</a> requests/national police certificate.jsp

On receipt of the NPC the applicant must present the letter for viewing and recording to Golf SA.

Where a person has no disclosable criminal history, the assessment is successfully completed and no further action in respect to an assessment is required.



Where an individual does have a criminal history, Golf SA <u>must</u> assess this information in accordance with Standard 5 of the *Standards for dealing with information obtained about the criminal history of employees and volunteers who work with children*. http://www.dcsi.sa.gov.au/pub/Default.aspx?tabid=281

Each assessment is conducted on its individual merits and with consideration to the inherent requirements of the position. As required by **the** *Standards for dealing with information obtained about the criminal history of employees and volunteers who work with children*, principles of procedural fairness and natural justice are applied throughout the decision-making process and the individual is provided an opportunity to confirm or dispute the information contained within the report and to provide contextual information for consideration during the assessment process.

Criminal history information will not be retained once a decision has been made regarding the person's suitability to work with children. No criminal history information will be retained beyond three months.

In accordance with its legal requirements, the organisation will retain the following information regarding its decision:

- That a criminal history report was obtained
- How the criminal history information affected decision making processes
- Statutory declarations (where applicable)

Golf Australia/Golf SA may obtain a further criminal history assessment for a staff member or volunteer at any time that they believe it necessary or desirable for the purpose of maintaining a child safe environment.

New applicants for employment, membership and volunteer positions will be provided with the opportunity to confirm or dispute the information contained within the National Police Certificate report and to provide contextual information if they wish before the assessment is conducted.

Golf Australia/Golf SA will communicate to the applicant the decision not to employ or engage them or to accept their application for membership. They will not be provided with the reasons for this decision.

There will be no appeal to this decision.

#### **Option 2**

A current letter of clearance from the Department for Communities and Social Inclusion (DSCI) Screening Unit is a requirement for all persons taking on a role in a prescribed position prior to their appointment and then at three yearly intervals.

The cost of obtaining a letter of clearance will be negotiated between the organisation the club or applicant.

Golf Australia/Golf SA may obtain a further criminal history assessment for an employee at any time that GA/GSA believes it necessary or desirable for the purpose of maintaining a child safe environment.

The informed written consent of the applicant or employee is required prior to conducting a criminal history assessment. The Screening Unit's informed consent form is available from <a href="http://www.dcsi.sa.gov.au/pub/Default.aspx?tabid=934">http://www.dcsi.sa.gov.au/pub/Default.aspx?tabid=934</a>

• Information relating to a person's criminal history and the assessment process is managed securely and confidentially and in accordance with the *Standards for dealing with information obtained* about the criminal history of employees and volunteers who work with children issued by the



• Chief Executive, Department for Families and Communities. http://www.dcsi.sa.gov.au/pub/Default.aspx?tabid=281

#### Other evidence (optional)

Where appropriate, GA/GSA may utilise a number of forms of evidence (obtained within the last three years) to assess a person's suitability to work with children. This includes:

- A National Police Certificate that does not expressly state that it cannot be used as a clearance to work with children
- A letter of clearance to work with children from the Department for Families and Communities Screening Unit
- A valid and current interstate working with children check.

Acceptance of other forms of evidence is at the discretion of the GA/GSA and is subject to the person completing a 100-point check to confirm the true identity of the applicant.

GA/GSA may also at its discretion seek a statutory declaration for any *employee(s)* or *volunteer(s)* who have been citizens or permanent residents of another country other than Australia since turning 18 years of age.

#### Exemptions from the requirement to conduct criminal history assessments

In accordance with guidelines the [NSO/organisation] has agreed to exempt the following persons from the requirement to undertake a criminal history assessment, unless that person is also involved in a function or event conducted by the [NSO/organisation] its affiliated associations or clubs which involves the care of children in overnight accommodation.

- A person volunteering in an activity in which their child ordinarily participates;
- A person who volunteers who is less than 18 years of age;
- A person working or volunteering for a short-term event or activity of less than 10 days duration or for no more than 1 day in any month;
- A person occupying a position in which all work involving children is undertaken in the physical presence of the child's parents or guardians and in which there is ordinarily no physical contact with the children:
- A person who undertakes, or a position that only involves, work that is primarily provided to adults or the community generally and is not provided to any child on an individual basis;
- An organisation that provides equipment, food or venues for children's parties or events but does not provide any other services to children;
- A person who has regular contact with a child as part of an employment relationship with that child (such as a person working alongside a child or supervising an employee who is a child);
- A person who is appointed as a police officer or is a registered teacher. (Police officers and teachers are already subject to comprehensive criminal history assessments as a prerequisite for employment).

#### 6. NORTHERN TERRITORY

The Care and Protection of Children Act 2007 (NT) highlights a number of initiatives the Northern Territory Government has designed to help keep children safe and prevent harm and exploitation of children, amongst other things.

From 1 July 2011, it will be mandatory for employees and volunteers aged 15 years and over who have contact or potential contact with children to hold a Working with Children Clearance (WWCC) Notice. Clearance Notices are designed to keep children safe by preventing those who pose a risk to the safety of children from working with them, in either paid or volunteer work. People who receive a WWCC Notice will receive an Ochre Card which acts as proof that you hold a WWCC Notice.

The Children Clearance Screening has three components:

- 1. A National Police Records Check;
- 2. Employment History; and
- 3. Other material

It is the responsibility of the person who wants to work or volunteer with children to apply for the WWCC Notice and ensure that it remains valid.

From the 1<sup>st</sup> of July, 2011, penalties will apply to people who gain employment in "child related" work without the WWCC Notice.

In some cases there will be people who will not require a WWCC Notice, Individual organisations may also have their own policies that require people working with children and young people to undergo a Police Check. #### 7. AUSTRALIAN CAPITAL TERRITORY

There is no formal legislation or relevant screening program in the ACT. Individual employers may require police checks at their discretion.

There are no legal statutes that require people working with children to undergo a police check. However, services contracted to the Government are required to employ "fit and proper" people. This is interpreted as a requirement to obtain a National Police Check. The Australian Federal Police provide National Police Checks for residents in the ACT.

#### 8. <u>TASMANIA</u>

Similar to the ACT, there is no formal legislation or relevant screening program in Tasmania. Individual employers may require police checks at their discretion.

A screening program does exist for persons engaged in the childcare industry. It is a requirement of the Department of Education that safety screening is undertaken for the following:

- Child care staff;
- Home base child carers; and
- Volunteers and students, including those under 18 years of age.

A Working with Children and other Vulnerable People Policy will be finalised and submitted for consideration of the Government and its anticipated legislation will be introduced into the Tasmanian Parliament in 2011. It is expected that the working with children checks will be phased in over five years commencing in 2011.

# PART D: COMPLAINT HANDLING PROCEDURES

#### Attachment D1: COMPLAINTS PROCEDURE

All complaints will be kept confidential and will not be disclosed to another person without the complainant's consent except if law requires disclosure or if disclosure is necessary to effectively deal with the complaint,

Individuals and organisations may also pursue their complaint externally under anti-discrimination, child protection or other relevant legislation.

If you wish to remain anonymous, Golf Australia may have difficulty assisting you to resolve your complaint. Procedural fairness (natural justice) means that Golf Australia is required to provide the person/people you have complained about with full details of the complaint so they have a fair chance to respond.

#### **INFORMAL APPROACHES**

#### Step 1: Talk with the other person (where this is reasonable, safe and appropriate)

In the first instance, you (the Complainant) should try to sort out the problem with the person or people involved (respondent) if you feel able to do so.

#### Step 2: Contact a Member Protection Information Officer

Talk with one of our MPIOs or an MPIO of the respective Affiliate Member or Affiliate Member Clubif:

- the first step is not possible/reasonable;
- you are not sure how to handle the problem by yourself;
- you want to talk confidentially about the problem with someone and obtain more information about what you can do; or
- the problem continues after you tried to approach the person or people involved.

To contact an MPIO please contact Golf Australia office or the office of the Affiliate Member or Affiliate Member Club. You should first go to your Club, then to your State/Territory Association and finally to Golf Australia. The progression should only be if satisfaction cannot be achieved at the lower level.

#### The MPIO will:

- take confidential notes about your complaint;
- try to find out the facts of the problem;
- ask what outcome/how you want the problem resolved and if you need support;
- provide possible options for you to resolve the problem;
- act as a support person if you so wish;
- refer you to an appropriate person (e.g. Mediator) to help you resolve the problem, if necessary;
- inform the relevant government authorities and/or police if required by law to do so;
- · maintain confidentiality.

#### Step 3: Outcomes from initial contact

After talking with the MPIO, you may decide:

- · there is no problem;
- the problem is minor and you do not wish to take the matter forward;
- to try and work out your own resolution (with or without a support person such as a MPIO; or
- to seek a mediated resolution with the help of a third person (such as a mediator or a Manager); or
- to seek a formal approach.



#### **FORMAL APPROACHES**

## Step 4: Making a Formal complaint

If your complaint is not resolved or informal approaches are not appropriate or possible, you may:

- make a formal complaint in writing to the CEO of Golf Australia or the respective Affiliated Member or Affiliated Member Club; or
- approach a relevant external agency such as an anti-discrimination commission, for advice.

On receiving a formal complaint and based on the material you have provided, the CEO of Golf Australia or the respective Affiliated Member or Affiliated Member Clubwill decide whether:

- they are the most appropriate person to receive and handle the complaint;
- the nature and seriousness of the complaint warrants a formal resolution procedure:
- to refer the complaint to mediation;
- to appoint a person to investigate (gather more information on) the complaint;
- to refer the complaint to a hearings tribunal;
- to refer the matter to the police or other appropriate authority; and/or
- to implement any interim arrangements that will apply until the complaint process set out in these Procedures is completed.

In making the decision(s) outlined above, the CEO of Golf Australia or the respective Affiliated Member or Affiliated Member Club will take into account:

- whether they have had any personal involvement in the circumstances which means that someone else should handle the complaint;
- your wishes, and the wishes of the respondent, regarding the manner in which the complaint should be handled;
- the relationship between you and the respondent (for example an actual or perceived power imbalance between you and the respondent);
- whether the facts of the complaint are in dispute; and
- the urgency of the complaint, including the possibility that you will be subject to further unacceptable behaviour while the complaint process is underway.

If the CEO of Golf Australia or the respective Affiliated Member or Affiliated Member Clubis the appropriate person to handle the complaint they will, to the extent that these steps are necessary:

- put the information they've received from you to the person/people you're complaining about and ask them to provide their side of the story;
- decide if they have enough information to determine whether the matter alleged in your complaint did or didn't happen; and/or
- determine what, if any, further action to take. This action may include disciplinary action in accordance with this policy.

#### Step 5: Investigation of the complaint

- A person appointed under Step 3 will conduct an investigation and provide a written report to the CEO of Golf Australia or the respective Affiliated Member or Affiliated Member Clubwho will determine what further action to take. This action may include a direction to the investigator to make further enquiries and obtain additional information, disciplinary action in accordance with Attachment D6, and referring the complaint to an informal or a formal mediation session, a Disciplinary Committee and/or the police or other appropriate authority;
- If the complaint is referred to mediation, it will be conducted in accordance with [Attachment D2] or as otherwise agreed by you and the respondent and the mediation provider;
- If the complaint is referred to a Disciplinary Committee, the hearing will be conducted in accordance with *Attachment D5*:
- If the complaint is referred to the police or other appropriate authority, Golf Australia will use its best endeavours to provide all reasonable assistance required by the police or other authority.



• It must be made clear to all parties that the investigator is not seeking to resolve the matter, nor to decide whether any breach of this Policy has occurred, nor to impose any penalty. Any decision about Policy breach must be referred to an independent tribunal, and wherever possible, mediations should be conducted by an independent mediator.

Any costs relating to the complaint process set out in this Policy (e.g. investigation and/or mediation and/or hearings tribunal) are to be met by [insert organisation] unless otherwise stated in the relevant Attachment.

#### Step 6: Reconsideration of initial outcome/investigation or appeal

If, under **Step 5**, an informal or formal mediation session is conducted, and you and the respondent(s) can not reach a mutually acceptable mediated solution to the complaint, you may request that the CEO of GA or the respective Affiliated Member or respective Affiliated Member Clubreconsider the complaint in accordance with **Step 4**.

You or the respondent(s) may be entitled to appeal where:

- under Step 4, a decision was made by the CEO of GA or the respective Affiliated Member or respective Affiliated Member Club:
  - o not to take any action; or
  - o to take disciplinary action; or
- under **Step 5**, a decision was made by the Disciplinary Committee:
  - o not to take any action; or
  - to take disciplinary action.

The grounds for appeal and the process for appeals under this Policy are set out in Attachment D5.

If the internal complaints processes set out in this Policy do not achieve a satisfactory resolution/outcome for you, or if you believe it would be impossible to get an impartial resolution within GA, you may choose to approach an external agency such as an equal opportunity commission to assist with a resolution.

# Step 7: Documenting the resolution

The CEO of Golf Australia or the respective Affiliated Member or Affiliated Member Club will document the complaint, the process and the outcome. This document will be stored in a confidential and secure place. If the complaint was dealt with at a state/district level, the information will be stored in the state association office. If the matter is of a serious nature, or if the matter was escalated to and/or dealt with at the national level, the original document will be stored at the national office with a copy stored at the state office.

#### **EXTERNAL APPROACHES**

There are a range of other options available depending on the nature of your complaint. If you feel that you have been harassed or discriminated against, you can seek advice from your State or Territory anti-discrimination commission without being obliged to make a formal complaint. If the commission advises you that the problem appears to be harassment within its jurisdiction, you may lodge a formal complaint with the commission.

Once a complaint is received by an anti-discrimination commission, it will investigate. If it appears that unlawful harassment or discrimination has occurred, the commission will conciliate the complaint confidentially. If this fails, or is inappropriate, the complaint may go to a formal hearing where a finding will be made. The tribunal will decide upon what action, if any, will be taken. This could include financial compensation for such things as distress, lost earnings or medical and counselling expenses incurred.



If you do lodge a complaint under anti-discrimination law, you may use an appropriate person (e.g. an MPIO) as a support person throughout the process. It is also common to have a legal representative, particularly at the hearing stage of a complaint.

You could alsoapproach another external agency such as the police.

#### **Attachment D2: MEDIATION**

Mediation is a process during which people in conflict are helped to communicate with each other to identify the areas of dispute and to make decisions about resolving it. This attachment outlines the general procedure of mediation that will be followed by Golf Australia.

- 1. The people involved in a formal complaint (complainant and respondent(s)) may work out their own resolution of the complaint or seek the assistance of a neutral third person or a mediator. Mediation may occur either before or after an investigation of the complaint.
- 2. Mediation (getting those involved to come to a joint agreement about how the complaint should be resolved) will only be recommended:
  - After the complainant and respondent have had their chance to tell their version of events to the CEO of GA or the respective Affiliated Member or respective Affiliated Member Club on their own; and
  - b. The CEO of GA or the respective Affiliated Member or respective Affiliated Member Clubdoes not believe that any of the allegations warrant any form of disciplinary action proven serious allegations will not be mediated, no matter what the complainant desires; and
  - c. Mediation looks like it will work (i.e. the versions given by the complainant and respondent tally or almost tally and/or at the very least, it looks as though it will be possible for each party to understand the other party's point of view).
- 3. Mediation will **not** be recommended if:
  - a. The respondent has a completely different version of the events and will not deviate from these;
  - b. The complainant or respondent are unwilling to attempt mediation;
  - c. Due to the nature of the complaint, the relationship between the complainant and the respondent(s) or any other relevant factors, the complaint is not suitable for mediation; or
  - d. The matter involves proven serious allegations, regardless of the wishes of the Complainant.
- 4. If mediation is chosen, the CEO of Golf Australia or the respective Affiliated Member or Affiliated Member Clubwill, under the direction of Golf Australia or the respective Affiliated Member or Affiliated Member Club and in consultation with the complainant and the respondent(s), arrange for a mediator.
- 5. The mediator's role is to assist the complainant and respondent(s) reach an agreement on how to resolve the problem. The mediator, in consultation with the complainant and respondent(s), will choose the procedures to be followed during the mediation. At a minimum, an agenda of issues for discussion will be prepared by the mediator.
- 6. The mediation will be conducted confidentially and without prejudice to the rights of the complainant and the respondent(s) to pursue an alternative process if the complaint is not resolved.
- 7. At the end of a successful mediation the mediator will prepare a document that sets out the agreement reached which will be signed by them as their agreement.
- 8. If the complaint is not resolved by mediation, the complainant may:
  - a. Write to CEO of Golf Australia or the respective Affiliated Member or Affiliated Member Clubto request that the CEO of Golf Australia or the respective Affiliated Member or Affiliated Member Clubreconsider the complaint in accordance with **Step 3**; *or*
  - **b.** Approach an external agency such as an anti-discrimination commission.



# **Attachment D3: INVESTIGATION PROCEDURE**

If an investigation needs to be conducted to gather more information the following steps will be followed:

- 1. We will provide a written brief to the investigator clarifying terms of engagement and roles and responsibilities. The investigator will:
  - 1.1 Interview the complainant and record the interview in writing.
  - 1.2 Convey full details of the complaint to the respondent (s) so that they can respond.
  - 1.3 Interview the respondent to allow them to answer the complaint, and record the interview in writing.
  - 1.4 Obtain statements from witnesses and other relevant evidence to assist in a determination, if there is a dispute over the facts
  - 1.5 Make a finding as to whether the complaint is:
    - substantiated (there is sufficient evidence to support the complaint);
    - inconclusive (there is insufficient evidence either way);
    - unsubstantiated (there is sufficient evidence to show that the complaint is unfounded); and/or
    - mischievous, vexatious or knowingly untrue.
  - 1.6 Provide a report to the CEO of Golf Australia or the respective Affiliated Member or Affiliated Member Clubdocumenting the complaint, investigation process, evidence, finding and, if requested, recommendations.
- We will provide a report to the complainant and the respondent(s) documenting the complaint, the investigation process and summarising key points that are substantiated, inconclusive, unsubstantiated and/or mischievous.
- The complainant and the respondent(s) will be entitled to support throughout this process from their chosen support person/adviser (e.g. MPIO or other person).
- 4. The complainant and the respondent(s) may have the right to appeal against any decision based on the investigation. Information on our appeals process is in [AttachmentD5].



# Attachment D4: HANDLING AN ALLEGATION OF CHILD ABUSE

An allegation of child abuse is a very serious matter and must be handled with a high degree of sensitivity. It is not the responsibility of anyone working in Golf Australia in a paid or unpaid capacity to decide whether or not child abuse has taken place. However, there is a responsibility to act on any concerns by reporting these to the appropriate authorities. The following outlines the key steps to follow. More information can be obtained from State or Territory government agencies.

### Step 1 - Initial Receipt of an Allegation

If a child or young person discloses an allegation involving harm or abuse to them or another child, then it is crucial that you:

- Stay calm;
- Listen, be supportive and do not challenge or undermine what the child says;
- Reassure the child that what has occurred is not the fault of the child;
- Be honest with the child and explain that other people may need to be told in order to stop what is happening;
- Ensure you are clear about what the child has said but do not elicit detailed information, ask leading questions or offer an opinion;
- Act promptly to accurately record the discussion in writing;
- Do not discuss the details with any person other than those detailed in these procedures; and
- Do not contact the alleged offender.

#### Step 2 - Report allegations

- Immediately report anyallegation or disclosure of child abuse or situation involving a child at risk of harm, to the police and/or government child protection agency. You may need to report to both.
- Contact the relevant child protection agency or police for advice if there is <u>any</u> doubt about whether
  the complaint should be reported (for example, the allegation may relate to poor/inappropriate
  practice).
- If the child's parent/s is suspected of committing the abuse, you should report the allegation to the relevant government agency.
- If the allegation involves anyone to whom our policy applies, then also report the allegation to the CEO of Golf Australia or the respective Affiliated Member or Affiliated Member Clubso that they can manage the situation (e.g. contact the parents following advice from the authorities, deal with any media enquiries and manage steps 3 and 4).

## Step 3 - Protect the child and manage the situation

- The CEO of Golf Australia or the respective Affiliated Member or Affiliated Member Clubwill assess
  the risks and take interim action to ensure the child's/children's safety. Action Golf Australia may
  implement includes redeployment of the alleged offender to a non-child related position, supervision
  of the alleged offender or removal/suspension from their duties until the allegations are finally
  determined.
- The CEO of Golf Australia or the respective Affiliated Member or Affiliated Member Clubwill consider the kind of support that the child/ren and parents may need (e.g. counselling, helplines, support groups).
- TheCEO of Golf Australia or the respective Affiliated Member or Affiliated Member Clubwill address the support needs of the alleged offender.
- The CEO of Golf Australia or the respective Affiliated Member or Affiliated Member Clubwill also put in place measures to protect the child and the person against whom the complaint is made from victimisation and gossip. If the person is stood down, it should be made clear to any persons aware of the incident that this does not mean the respondent is guilty and a proper investigation will be undertaken.

#### Step 4 - Internal action

 Where there is an allegation made against a person to whom this policy applies, there may be three types of investigations:



- Criminal (conducted by police)
- o Child protection (conducted by child protection authority)
- Disciplinary or misconduct (conducted by Golf Australia)
- Irrespective of the findings of the child protection and/or police inquiries Golf Australia will assess the allegation to decide whether the person should be reinstated, banned, have their employment or position terminated or any other action.
- The decision-maker will be the Disciplinary Committee of Golf Australia and it will consider all the information, including the findings of the police, government agency and/or court, and determine a finding, recommend action and explain its rationale for the action. This may be a difficult decision particularly where there is insufficient evidence to uphold any action by the police.
- If disciplinary action is to be taken, the procedures outlined in [Clause 9] of the policy will be followed.
- If disciplinary action is taken, Golf Australia will advise and provide a report to the relevant government authority should this be required (e.g. the NSW Commission for Children and Young People requires notification of relevant employment proceedings).



# Attachment D5: HEARINGS & APPEALS TRIBUNAL PROCEDURE

The following will be followed by the Disciplinary Committee of Golf Australia or their Affiliate Member or Affiliate Member Club to hear complaints made under this policy. Golf Australia should check and ensure that this procedure accurately reflects their tribunal rules and procedure, constitution and bylaws.

# **Preparation for Committee Hearing**

- 1. A Tribunal Panel will be constituted following the rules outlined in Golf Australia's Constitution, to hear a complaint that has been referred to it by theCEO of Golf Australia or the respective Affiliated Member or Affiliated Member Club. The number of Committee members required to be present throughout the hearing will be three.
- The Committee members will be provided with a copy of all the relevant correspondence, reports or information received and sent by the CEO of Golf Australia or the respective Affiliated Member or Affiliated Member Clubrelating to the complaint/allegations.
- 3. The Committee hearing will be scheduled as soon as practicable, but must allow adequate time for the person being complained about (respondent(s)) to prepare their case for the hearing.
- 4. The Committee Panel will not include any person who has any actual or perceived conflict of interest, or bias regarding the matter.
- 5. The CEO of Golf Australia or the respective Affiliated Member or Affiliated Member Club will inform the respondent(s) in writing that a tribunal hearing will take place. The notice will outline:
  - That the person has a right to appear at the tribunal hearing to defend the complaint/allegation;
  - Details of the complaint, and details of all allegations and the clause of any policy or rule allegedly breached;
  - The date, time and venue of the Committee hearing;
  - That they can make either verbal or written submissions to the Committee;
  - That they may arrange for witnesses to attend the Committee in support of their position (statutory declarations of witnesses not available or from character witnesses may also be provided to the Committee);
  - An outline of any possible penalties that may be imposed if the complaint is found to be true: and
  - That legal representation will not be allowed. If the respondent is a minor, they should have a parent or guardian present

A copy of any information / documents that have been given to the Committee (e.g. investigation report findings) will also be provided to the respondent.

The respondent(s) will be allowed to participate in all Golf Australia activities and events, pending the decision of the Committee, including any available appeal process, unless the CEO of Golf Australia or the respective Affiliated Member or Affiliated Member Clubbelieves it is necessary to exclude the respondent(s) from all or some Golf Australia activities and events, after considering the nature of the complaint.

- 6. The CEO of Golf Australia or the respective Affiliated Member or Affiliated Member Clubwill notify the complainant in writing that a Committee hearing will take place. The notice will outline:
  - That the person has a right to appear at the Committee hearing to support their complaint;
  - Details of the complaint, including any relevant rules or regulations the respondent is accused of breaching
  - The date, time and venue of the Committee hearing;
  - That they can make either verbal or written submissions to the Committee:
  - That they may arrange for witnesses to attend the Committee in support of their position (or provide statutory declarations from witnesses unable to attend); and
  - That legal representation will not be allowed. If complainant is a minor, they should have a
    parent or guardian present.



- A copy of any information / documents that have been given to the Committee (e.g. investigation report findings) will also be provided to the complainant.
- 7. If the complainant believes the details of the complaint are incorrect or insufficient they should inform the CEO of Golf Australia or the respective Affiliated Member or Affiliated Member Clubas soon as possible so that the respondent and the Committee Panel members can be properly informed of the complaint.
- 8. It is preferable that the Committee include at least one person with knowledge or experience of the relevant laws/rules (e.g. Discrimination).

#### **Tribunal Hearing Procedure**

- The following people will be allowed to attend the Committee Hearing:
  - The Committee members:
  - The respondent(s);
  - The complainant;
  - Any witnesses called by the respondent;
  - Any witnesses called by the complainant;
  - Any parent / guardian or support person required to support the respondent or the complainant.
- 10. If the respondent(s) is not present at the set hearing time and the Committee Chairperson considers that no valid reason has been presented for their absence, the Committee Hearing will continue subject to the Committee Chairperson being satisfied that all Committee notification requirements have been met.
- 11. If the Committee Chairperson considers that a valid reason for the non-attendance of the respondent(s) has been presented, or the Committee Chairperson does not believe the Committee notification requirements have been met, then the Committee will be rescheduled to a later date.
- 12. The Committee Chairperson will inform the CEO of Golf Australia or the respective Affiliated Member or Affiliated Member Clubof the need to reschedule, and the CEO of Golf Australia or the respective Affiliated Member or Affiliated Member Clubwill organise for the Committee to be reconvened.
- 13. The Committee Chairperson will read out the complaint, ask the respondent(s) if they understand the complaint and if they agree or disagree with the complaint.
- 14. If the respondent agrees with the complaint, he or she will be asked to provide any evidence or witnesses that should be considered by the Committee Panel when determining any disciplinary measures (penalty).
- 15. If the respondent disagrees with the complaint, the complainant will be asked to describe the circumstances that lead to the complaint being made.
  - Reference may be made to brief notes.
  - The complainant may call witnesses.
  - The respondent(s) may question the complainant and witnesses.
- 16. The respondent(s) will then be asked to respond to the complaint.
  - Reference may be made to brief notes.
  - The respondent may call witnesses.
  - The complainant may ask questions of the respondent and witnesses.
- 17. Both the complainant and respondent may be present when evidence is presented to the Committee. Witnesses may be asked to wait outside the hearing until required.
- 18. The Committee may:
  - consider any evidence, and in any form, that it deems relevant.
  - question any person giving evidence.
  - limit the number of witnesses presented to those who provide any new evidence.
  - Require (to the extent it has power to do so) the attendance of any witness it deems relevant;
  - Act in an inquisitorial manner in order to establish the truth of the issue/case before it.
- 19. Video evidence, if available, may be presented. The arrangements must be made entirely by the person/s wishing to offer this type of evidence.



- 20. If the Committee considers that at any time during the Committee Hearing there is any unreasonable or intimidatory behaviour from anyone, the Chairperson may deny further involvement of the person in the hearing.
- 21. After all of the evidence has been presented the Committee will make its decision in private. The Committee must decide whether the complaint has been substantiated on the balance of probabilities (i.e. more probable than not). As the seriousness of the allegation increases, so too must the level of satisfaction of the Committee that the complaint has been substantiated. The respondent will be given an opportunity to address the Committee on disciplinary measures which might be imposed. Disciplinary measures imposed must be reasonable in the circumstances.
- 22. All Committee decisions will be by majority vote.
- 23. The Committee Chairperson will announce the decision in the presence of all those involved in the hearing and will declare the hearing closed, or may advise those present that the decision is reserved and will be handed down in written form at a later time.
- 24. Within 48 hours, the Committee Chairperson will:
  - Forward to the CEO of Golf Australia or the respective Affiliated Member or Affiliated Member Cluba notice of the Committee decision including any disciplinary measures imposed.
  - Forward a letter to the respondent(s) reconfirming the Committee decision and any
    disciplinary measures imposed. The letter should also outline, if allowed, the process and
    grounds for an appeal .Where the matter is of unusual complexity or importance, the
    Committee Chairperson may inform the parties in writing within 48 hours that the decision will
    be delayed for a further 48 hours.
- 25. The Committee does not need to provide written reasons for its decision.

#### **Appeals Procedure**

NB. The initial determination applies until an appeal is heard and continues to apply if the Appeal Tribunal affirms or agrees with the Determination.

- 26. A complainant or a respondent(s) who is not satisfied with the outcome of mediation or a Disciplinary Committee decision can lodge one appeal toGolf Australia or the respective Affiliated Member or Affiliated Member Club on one or more of the following bases:
  - 26.1 That a denial of natural justice has occurred; or
  - 26.2 That the disciplinary measure(s) imposed is unjust and/or unreasonable.
  - 26.3 That the decision was not affected by bias.
- 27. A person wanting to appeal in accordance with clause 23 must lodge a letter setting out the basis for their appeal with theCEO of Golf Australia or the respective Affiliated Member or Affiliated Member Club by 5:00pm (Australian Eastern Standard Time) on the second business day after the respondent has been informed of the Determination. An appeal fee of \$500(which is refundable if the Determination is changed or overturned in mediation or by the Appeals Tribunal) shall be included with the letter of intention to appeal.
- 28. If the letter of appeal is not received by the CEO of Golf Australia or the respective Affiliated Member or Affiliated Member Clubwithin the time period the right of appeal lapses. If the letter of appeal is received but the appeal fee is not received by the relevant time, the appeal lapses.
- 29. The letter of appeal and notice of Committee decision (clause 24) will be forwarded to the Appeals Tribunalto review and decide whether there are sufficient grounds for the appeal to proceed. The Appeals Tribunal may invite any witnesses to the meeting it believes are required to make an informed decision.
- 30. If the appellant has not shown sufficient grounds for appeal in accordance with clause 26, then the appeal will be rejected. The appellant will be notified with reasons. The appeal fee will be forfeited.



- 31. If the appeal is accepted the appeal fee will be refunded and the following process will be followed:
  - 31.1 Consultation and mediation the appellant, the Chair of the Committee, and the relevant expert must meet (with a Mediator as facilitator) to discuss the Determination;
  - 31.2 If the parties do not reach agreement by consultation and mediation within seven (7) working days (or a shorter period reasonably determined by Golf Australia) after the respondent gives notice under clause 27, the respondent may request in writing that the matter be heard by the Appeal Tribunal.
  - 32. The Appeal Tribunal will consist of the following persons appointed by the Board:
    - 32.1 a barrister or solicitor, who will act as chairman;
    - 32.2 a person with a thorough knowledge of the matter; and
    - 32.3 another independent expert with knowledge specifically relevant to the matter, or as specified in the specific by-law.
  - 33. Such appointments will be for a calendar year.
  - 34. If a member of the Appeal Tribunal is unable to sit for a particular hearing, the Board will appoint another person as a member for that hearing.
  - 35. A person who is:
    - 33.1 a member of the Board or of the Committee; or
    - 33.2 by reason of his or her relationship with:
      - the appellant concerned;
      - ii. any member of the Board or the Committee; or
      - iii. any person whose interest may be affected by the outcome of the appeal,

is not eligible to be appointed to the Appeal Tribunal.

- 36. The Appeal Tribunal will convene a hearing as soon as practicable at the discretion of Golf Australia, but in any event not more than seven (7) working days, after the submission of the grounds of appeal by the appellant.
- 37. If the appellant concerned challenges the impartiality of any member of the Appeal Tribunal, the challenge will be determined by the members of the Tribunal other than the member challenged.
- 38. The hearing may occur in such manner as the chairman decides, including by telephone or video conference.
- 39. In any hearing before the Appeal Tribunal:
  - 37.1 the tribunal must observe the rules of natural justice;
  - 37.2 the tribunal is not bound by the rules of evidence and may inform itself as to any matter in such manner as it thinks fit;
  - 37.3 the appellant must establish one or more grounds of appeal to the reasonable satisfaction of the tribunal with full regard to the importance and gravity of the issue;
    - i. if a question of law arises during the course of the hearing, the appellant or Golf Australia may seek an adjournment in order to obtain legal advice; and
- 40. neither the appellant nor Golf Australia is entitled to be represented by a barrister or solicitor, except with the leave of the tribunal, which leave will only be granted in exceptional circumstances. The Appeal Tribunal will give its decision as soon as practicable after the hearing and will provide Golf Australia's CEO and the appellant with the decision.
- 41. An appellant may withdraw his or her appeal by written notice to Golf Australia at any time before the appeal has been decided.
- 42. The decision of the Appeal Tribunal will be final.



# PART E: REPORTING REQUIREMENT AND DOCUMENTS

### General principles to be followed when completing a report of a complaint:

- Treat all complaints seriously.
- Deal with complaints promptly, sensitively and confidentially.
- Maintain a calm attitude.
- Ask the complainant if they will consent to you taking notes.
- Write the description of the complaint /problem using the complainants own words (as much as is possible).
- Find out the nature of the relationship between the complainant and the person complained about (for example, coach/competitor, team members, etc.) and if there is any relevant history.
- Take a note of the facts and do not pre-judge the situation.
- Ask the complainant whether they fear victimisation or other consequences.
- Find out what outcome the complainant wants and if they need any support.
- Ask the complainant how they want to the complaint to be dealt with under the policy.
- Keep the complaint confidential and do not disclose it to another person without the complainant's
  consent except if disclosure is required by law (for example, a report to government authorities) or if
  disclosure is necessary to effectively deal with the complaint.

The following information was updated in November 2011. It is subject to change at any time.

#### **QUEENSLAND**

If you have a reason to suspect a child in Queensland is experiencing harm, or is at risk of experiencing harm, you need to contact <u>Child Safety Services</u>:

- During normal business hours contact the Regional Intake Service.
- After hours and on weekends contact the Child Safety After Hours Service Centre on 1800 177 135 or (07) 3235 9999. The service operates 24 hours a day, seven days a week.

If you believe a child is in immediate danger or in a life-threatening situation, contact the Queensland Police Service immediately by dialling **000**.

Queensland Police Service has a number of child protection and investigation units across Queensland. To contact the Queensland Police Service, contact the <u>Police District Communication Centre</u> nearest you.

If you aren't sure who to call, or for assistance to locate your nearest child safety service centre, contact Child Safety Services' Enquiries Unit on **1800 811 810**. Child safety service centres have professionally trained child protection staff who are skilled in dealing with information about harm or risk of harm to children.

#### **NEW SOUTH WALES**

Anyone who suspects, on reasonable grounds, that a child or young person is at risk of being neglected or physically, sexually or emotionally abused, should report it to Community Services.



Reasonable grounds is the standard that reporters must use in deciding whether or not to report to Community Services.

It does not mean that reporters are required to confirm their suspicions or provide solid proof before making a report. A useful rule of thumb is to consider whether another person, when faced with similar information, would also draw the same conclusion.

You can make a report by phoning the **Child Protection Helpline on 132 111** (TTY 1800 212 936) for the cost of a local call, 24 hours a day, 7 days a week.

#### **WESTERN AUSTRALIA**

If you are concerned about a child's wellbeing, <u>contact</u> the Department for Child Protection's district office closest to where the child lives or the <u>Crisis Care Unit</u> after hours.

If you believe a child is in immediate danger or in a life-threatening situation, contact the Western Australia Police immediately by dialling **000**.

If you make a report or disclose relevant information to the Department for Child Protection, there is legislative protection for the notifier. These are:

- Protection of identity with some exceptions, your identity must not be disclosed without your consent. For further information, refer to section 240 of the *Children and Community Services* Act 2004
- Legal protection you are not subject to legal liability under State law providing the information is provided in good faith.
- Professional protection authorised disclosure of information cannot be held to constitute unprofessional conduct or a breach of professional ethics. As a result you cannot be disciplined by your professional body or incur any formal professional negative consequences at your workplace.

When you contact the Department, the Duty Officer will gather and record information that you provide and decide how best to respond. The type of information that the officer will gather includes:

- · details about the child/young person and family
- the reasons you are concerned
- · the immediate risk to the child
- whether or not the child or family has support
- what may need to happen to make the child safe
- your contact details, so that the officer can call you to obtain further information if required or to provide feedback.

You do not need to have all the details about the child or family when you contact the Department for Child Protection

## **VICTORIA**

Some professionals such as doctors, nurses, police and school teachers are legally obliged to report suspected child abuse. In addition, any person who believes on reasonable grounds that a child needs protection can make a report to the Victorian Child Protection Service. It is the Child Protection worker's job to assess and, where necessary, further investigate if a child or young person is at risk of harm.

#### **SOUTH AUSTRALIA**

Staff and volunteers who work with children are mandated notifiers and have a legal obligation to report any suspicion of child abuse and/or neglect that they may form in the course of their employment or volunteer activity based on reasonable grounds. This obligation extends to persons holding a management position whose duties include direct responsibility for, or direct supervision of the provision of services to children.

Reports are made to the CHILD ABUSE HELP LINE 13 14 78

A reasonable suspicion must be based on facts, for example:

- A disclosure of abuse by a child
- Professional judgement, based on the notifier's experience and observations

The organisation has an obligation to make each affected person aware of this legal obligation.

There is no obligation that recreation or sporting organisations require mandated reporters to undertake formal external training in the recognition of child abuse.

The law also stipulates that no person shall threaten or intimidate, or cause damage, loss or disadvantage to another person because that person has made a notification or proposes to make a notification pursuant to the *Children's Protection Act 1993*.

#### NORTHERN TERRITORY

In the Northern Territory any person who believes that a child is being, or has been, abused or neglected is required by law to report their concerns.

Reports should be made to the 24 hour Centralised Intake Service by using the free-call phone number 1800 700 250.

Remember, you do not need to prove abuse or neglect, you need only report your concerns. The Care and Protection of Children Act provides legal protection against civil or criminal liability for people who make reports in good faith.

The Act also makes it clear that making a report does not breach any requirements of confidentiality or professional ethics.

#### **AUSTRALIAN CAPITAL TERRITORY**

Care and Protection services is responsible for facilitating coordination across government for the care and protection of children and young people. Care and Protection services and an After Hours service, provide a continuum of service delivery to children and young people considered 'at risk' of serious harm.

Care and Protection Services is authorised to collect personal information under the *Children and Young People Act 2008* to ensure the safety and wellbeing of children and young people in the ACT. The information collected may be disclosed to government and non government agencies (including but not limited to the Australian Federal Police, ACT Children's Court, the Family Court, Health and Education Directorates and community organisations) to assist in ensuring the safety and wellbeing of children and young people. Information identifying a person making a child protection report is treated with the highest confidentiality and will not be disclosed except where a Court orders the disclosure.

#### **TASMANIA**

Most professionals who provide services to children and families in Tasmania are 'mandatory reporters' of child abuse, under the Children, Young Persons and their Families Act 1997. This includes, but is not limited to, the following groups:

- DHHS employees
- Child Care providers
- Dentists, dental therapists or dental hygienists
- Police officers and probation officers
- Psychologists
- Registered medical practitioners and nurses
- School principals and teachers
- Volunteers and employees of any organisation that provides health, welfare, education, care or residential services and which receives government funding.

To make an urgent notification about abuse or neglect to Child Protection Services, please ring 1300 737 639 at any time.

Child Protection Services prefer to talk to a notifier in order to aid them in gathering information. However, if it is after hours and you are a mandatory reporter, an online notification can also be made.
